TAA representatives do not have authority to bind TAA with oral statements or agreements. Fax or electronic signatures of company and TAA are binding.

7. Company acknowledges that this is a "qualified sponsorship payment," consistent with Internal Revenue Code §513(i), and expects no substantial return benefit as a result of the sponsorship.
